## 4.1. Description of first aid measures

### General information

In all cases of doubt, or when symptoms persist, seek medical advice. In case of unconsciousness give nothing by mouth, place in recovery position and seek medical advice.

### In case of inhalation

Remove casualty to fresh air and keep warm and at rest. In case of irregular breathing or respiratory arrest provide artificial respiration.

### Following skin contact

Storage in accordance with the Ordinance on Industrial Safety and Health (BetrSIVVO). Keep container tightly closed. Do not empty containers with pressure - no pressure vessel! Smoking is forbidden.
